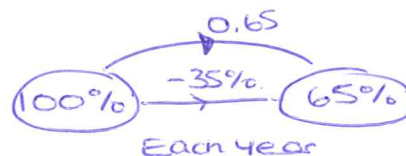
1. Toby invested £4500 for 2 years in a savings account.  
He was paid 4% per annum compound interest.

How much did Toby have in his savings account after 2 years?

$$4500 \times 1.04^2 = £4867.20$$

£ 4867.20

2. The value of a car depreciates by 35% each year.  
At the end of 2007 the value of the car was £5460  
Work out the value of the car at the end of 2006



$$\begin{aligned} \text{Value}_{2006} \times 0.65 &= \text{Value}_{2007} \\ \text{Value} \times 0.65 &= £5460 \\ \text{Value} &= 5460 \div 0.65 \\ &= 8400 \end{aligned}$$

£ 8400

3. Mario invests £2000 for 3 years at 5% per annum **compound** interest.  
Calculate the value of the investment at the end of 3 years.

$$2000 \times 1.05^3 = £2315.25$$

4. Derek invests £154 500 for 2 years at 4% per year compound interest.  
Work out the value of the investment at the end of 2 years.

$$154500 \times 1.04^2 = £167107.20$$

5. Henry invests £4500 at a compound interest rate of 5% per annum.

At the end of  $n$  complete years the investment has grown to £5469.78.

Find the value of  $n$ .

$$\begin{aligned}4500 \times 1.05^n &= 5469.78 \\1.05^n &= 5469.78 \div 4500 \\&= 1.2155066\dots\end{aligned}$$

$$\begin{aligned}1.05^2 &= 1.1025 \\1.05^3 &= 1.157625 \\1.05^4 &= 1.215506\dots \\1.05^5 &= 1.276281\dots\end{aligned}$$

$$n = 4$$

6. A company bought a van that had a value of £12 000  
Each year the value of the van depreciates by 25%.

Work out the value of the van at the end of three years.

Each year:  $(100\%) \xrightarrow{-25\%} (75\%)$   
 $\downarrow$

$$12000 \times 0.75^3 = \pounds 5062.50$$

$$\pounds \underline{5062.50}$$

7. Bill invests £500 on 1st January 2004 at a compound interest rate of  $R\%$  per annum.  
The value, £ $V$ , of this investment after  $n$  years is given by the formula

$$V = 500 \times (1.045)^n$$

- (a) Write down the value of  $R$ .

$$1.045 = 104.5\%$$

$$R = \dots 4.5\% \dots$$

- (b) Use your calculator to find the value of Bill's investment after 20 years.

$$\begin{aligned} V &= 500 \times 1.045^{20} \\ &= \pounds 1205.8570\dots \\ &= \pounds 1205.86 \end{aligned}$$

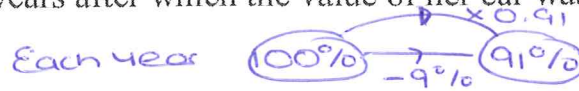

8. Gwen bought a new car.  
Each year, the value of her car depreciated by 9%.

Calculate the number of years after which the value of her car was 47% of its value when new.



$$\cancel{0.47V} \approx$$

$$0.47V = V \times 0.91^n$$

$$(\div V) \quad 0.47 = 0.91^n$$

$$0.91^4 = 0.6857\dots$$

$$0.91^6 = 0.5678\dots$$

$$0.91^7 = 0.5167\dots$$

$$0.91^8 = 0.4702\dots$$

$$0.91^9 = 0.4279\dots$$

8 years

9. Liam invests £6200 for 3 years in a savings account.  
He gets 2.5% per annum compound interest.

How much money will Liam have in his savings account at the end of 3 years?

$$6200 \times 1.025^3 = £6676.7218\dots$$

$$= £6676.72$$

£ 6676.72

10. Toby invested £4500 for 2 years in a savings account.  
He was paid 4% per annum compound interest.

(a) How much did Toby have in his savings account after 2 years?

$$4500 \times 1.04^2 = £4867.20$$

£ 4867.20.....

Jaspir invested £2400 for  $n$  years in a savings account.  
He was paid 7.5% per annum compound interest.

At the end of the  $n$  years he had £3445.51 in the savings account.

(b) Work out the value of  $n$ .

$$\begin{aligned} 2400 \times 1.075^n &= 3445.51 \\ 1.075^n &= 3445.51 \div 2400 \\ 1.075^n &= 1.435629\dots \end{aligned}$$

$$\begin{aligned} 1.075^3 &= 1.24229\dots \\ 1.075^4 &= 1.33546\dots \\ \underline{1.075^5} &= \underline{1.43562\dots} \\ 1.075^6 &= 1.54330\dots \end{aligned}$$

$n=5$ .....

\*11 Viv wants to invest £2000 for 2 years in the same bank.

<p><b>The International Bank</b></p> <p>Compound Interest</p> <p>4% for the first year</p> <p>1% for each extra year</p>

<p><b>The Friendly Bank</b></p> <p>Compound Interest</p> <p>5% for the first year</p> <p>0.5% for each extra year</p>
---

At the end of 2 years, Viv wants to have as much money as possible.

Which bank should she invest her £2000 in?

The International Bank

$$\text{End 1st Year: } 2000 \times 1.04$$

$$\text{End 2nd Year: } (2000 \times 1.04) \times 1.01 \\ = \text{£}2100.80$$

The friendly Bank

$$\text{End 1st Year: } 2000 \times 1.05$$

$$\text{End 2nd Year: } (2000 \times 1.05) \times 1.005 \\ = \text{£}2110.50$$

Viv should invest her money in The friendly Bank, this will give her £9.70 more at the end of two years.
